Validity:

Quotes are valid for 30 days. If parts are quoted from stock, they are subject to prior sale.

Minimum Value:

Domestic purchase orders have a minimum order of \$75 USD. International purchase orders have a minimum of \$150 USD

Fees:

\$10 handling fee applies to orders under \$1000. Wire fees are the responsibility of the customer. Credit card orders are subject to 3% processing fee.

Returns:

No returns are accepted without prior authorization. We will bill the full amount if no RMA is issued. 35% restocking fee will apply to any material returned without justification.
